Lubliniec, 16-19 October 2025

Conference

We invite you to participate in the Annual Conference of the Mineralogical Society of Poland entitled "How Can Mineralogical Sciences Support the Mineral Resources Industry?", which will be held from October 16th to 19th, 2025, in Lubliniec (Silesian Voivodeship). The conference will be focused on broad range of topics in mineralogical and petrological research. We also anticipate special sessions related to the application of mineralogical sciences in the study of primary (exploration of mineral deposits) and secondary sources of mineral raw materials (recycling).

Venue

The venue for the Conference will be the city of Lubliniec in Upper Silesia. Lubliniec, situated at the junction of the Upper Silesian and Małopolska blocks, within the Kraków-Lubliniec fault zone, is located in the vicinity of significant Polish areas of mineral deposit occurrence: the Mississippi Valley Type Pb-Zn-Ag deposits in the Tarnowskie Góry region, sedimentary iron deposits of the Częstochowa region, and porphyry Cu-Mo-W deposits of the Myszków region.
